Registered in 1972, we are the standard bearer for financial markets' professionals in Singapore. Our history has been inextricably linked to Singapore's emergence as a leading financial centre in the world.

Financial Markets Association of Singapore (formerly known as ACI Singapore) is affiliated to ACI – The Financial Markets Association (ACI FMA), a Paris-based global umbrella body of financial markets associations. The Association was officially renamed to Financial Markets Association of Singapore on 31st March 2021 to reflect a stronger focus on the domestic agenda and is still affiliated with ACI FMA.

Golf Tournament Rules

Registration / Tee-Off

- 11.30am Registration opens and collection of Goodie Bag.
- Please arrive and register at least 1.15 hours or earlier before 1.15 pm. This is to ensure ample time for lunch.
- An International Buffet lunch will be served at Greenhouse Restaurant.

Starting Time (PM Shotgun)

- Golfers are kindly requested to arrive and register 1 hour before the shotgun starts at 1.15pm.
- All golfers to assemble just below the Golfers' Buggy station at about 1pm for a group photo taking session.
- All competitors are to head to their buggy immediately after the group photo, to get ready to move off to tee boxes.
- All men will tee-off from the **WHITE** tees while the ladies will tee-off from the **RED** tees.

Rules & Regulation

Format of Play: "DOUBLE PEORIA"

FMAS Charity Golf 2025 is a tournament consisting of a single round of 18 holes played in Double Peoria format. Rules of golf as approved by the R & A, USGA and the local rules of Laguna National Golf Resort Club.

Golfers will play and record the gross score for each hole.

At the end of the tournament, the Organising Club will select twelve Blind Holes, The System will then exclude these six selected holes and use the remaining 12 holes to compute the golfer's handicap using the formula:

Handicap = ((Sum of Gross for 12 holes) – 48) x 1.2

The System will then use this computed handicap to compute the golfer's nett score for all 18 holes and the winner is the player with the best nett score, using the countback with Laguna National Golf Resort Club System. The committee's Decision will be final.

Tournament consist of

1. **The Team Event** will consist of the best three players, Stableford Points from their respective flight for each hole played according to their Double Peoria calculated handicap for the day, played over 18 holes. Prizes will be for the Champion Team, 1st Runner-up Team and 2nd Runner up Team.

Gimme Putt

A Gimme shall apply when the ball lies within a putt length not including its grip. Pick up the ball and add one stroke to the score.

Golf Tournament Rules

Score Card Return

- All score Cards must be submitted to the officials after the round. Please enter only the GROSS score.
- Please do check that all your scores are entered correctly. Incorrect / incomplete scores, a default score of Double par + 2 strokes (*R&A + 2) will be submitted instead of an empty score for each hole.
- Laguna National Golf Resort Club, on behalf of the FMAS Charity Golf 2025 Tournament Committee will compute the results for the Tournament. The organiser decision will be final.

Course Etiquette

In the interest of all players in the tournament, please ensure that your flight is able to keep up with preceding flight. The Tournament organisers and LNGRC officials reserve the right to make suggestions to players and their flights to speed up play. To speed up play, if you cannot contribute points towards the team score, please pick up your ball. Please note to adhere to all safe management measures and Laguna National rules must be strictly adhere to.

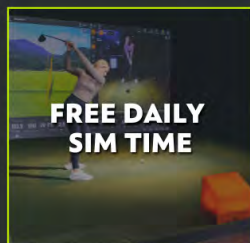

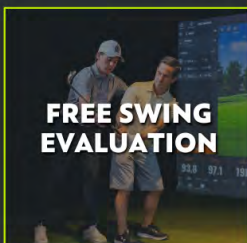
