FINANCIAL MARKETS ASSOCIATION OF SINGAPORE: HISTORY

Formed in 1972, we are the standard bearer for financial markets' professionals in Singapore. Our history has been inextricably linked to Singapore's emergence as a leading financial centre in the world. Financial Markets Association of Singapore (FMAS), formerly known as the ACI Singapore - The Financial Markets Association of Singapore, has undergone significant changes in recent years in response to structural changes taking place in the financial markets. On 31st March 2021, the Association was officially renamed to Financial Markets Association of Singapore, to become the standard bearer for financial markets professionals in Singapore.

The Constitution was amended to encompass these changes. As a result, we are now multidisciplinary and members represent all major areas of the industry, including financial markets professionals employed in corporations, financial markets academics and professionals/vendors engaged to providing products & services to the financial markets. The membership will also fully embrace our important colleagues who support the treasury businesses in the middle & back offices.

AFFILIATION

Financial Markets Association of Singapore (FMAS) is affiliated to ACI - The Financial Markets Association which is the global umbrella body of national forex associations. It has over 8,000 international members worldwide in more than 60 countries. This makes ACI the largest international association in the wholesale financial markets.

COLLABORATION

Locally, Financial Markets Association of Singapore (FMAS) works closely with the Singapore Foreign Exchange Market Committee (SFEMC), other market bodies and academic institutions. Internationally, the Association liaises closely with ACI FMA, ACI Asia and other national associations, particularly those in the Asia-Pacific region.

MEMBERSHIP

There are six (6) types of membership:

- (a) Ordinary (Individual)
- (b) Associate (Individual)
- (c) Ordinary Institutional
- (d) Associate Institutional
- (e) Alumni
- (f) Honorary

(a) **Ordinary (Individual) Membership** may be offered, at the sole discretion of the Committee to all Wholesale Traded Financial Markets Practitioners carrying out Front Office activities and Front Office Support Professionals who:

- i. are employed in a financial institution regulated and/or supervised by the MAS (where such financial institution is established registered in Singapore) or by any other official regulatory authority (where such financial institution is established or registered outside of Singapore); and,
- ii. have been employed under such qualifying criteria in the forgoing Clause 5(a)(i) above for a continuous period of at least twelve (12) months.

(b) **Associate (Individual) Membership** shall be open for applicants who fall within any one or more of the following categories:

- i. individuals falling outside the categories set out in Clause 5(b) but who satisfy such criteria as may be prescribed by the Committee; or,
- ii. corporations which do not meet the criteria in Clause 5(f) but have a business which is related to Wholesale Traded Financial Products.

(c) **Ordinary Institutional Membership** may be offered, at the sole discretion of the Committee, to any corporation which has a business that is:

- i. regulated and/or supervised by the MAS or by any other official regulatory authority; and,
- ii. related to Wholesale Traded Financial Products

(d) **Associate Institutional Membership** may be offered, at the sole discretion of the Committee, to any corporation which has a business that is:

- i. regulated and/or supervised by the MAS or by any other official regulatory authority;
- ii. related to Wholesale Traded Financial Products; or,
- iii. corporations which do not meet the criteria in Clause 5(e) or 5(f) but that satisfy such criteria as may be prescribed by the Committee.

- (e) **Alumni Membership** shall be open to individuals who had previously qualified for Ordinary (Individual) Membership but had since left the employment of their former institutions.
- (f) **Honorary Membership** is granted by the Executive Committee to selected members in recognition of services rendered.

- Ordinary (Individual) Membership, \$150.00 annually
- Associate (Individual) Membership, \$125.00 annually
- Alumni Membership, \$125.00 annually
